Pursuant to Section 4 of the Natural Gas Act ("NGA") and Part 154 of the Federal Energy Regulatory Commission's ("FERC" or "Commission") regulations¹ and to comply with the Commission's Order to Show Cause issued on March 20, 2014, in Docket No. RP14-442-000,² Gas Transmission Northwest LLC ("GTN") respectfully submits for filing new tariff section 6.15.16, included as Appendix A, to be part of its FERC Gas Tariff, Fourth Revised Volume No. 1-A ("Tariff").³ GTN respectfully requests that the Commission accept Section 6.28.12 to become effective June 12, 2014.

Statement of Nature, Reasons, and Basis for Filing

In its Show Cause Order, the Commission required that all interstate pipelines submit filings to either revise their tariffs to provide for the posting of offers to purchase released capacity or otherwise demonstrate full compliance with the Commission's regulations. Specifically, Section 284.8(d) of the Commission's regulations⁴ requires pipelines to provide notice of offers to purchase released capacity and to post the terms and conditions of such offers on their Internet websites for a reasonable period.

To comply with Ordering Paragraph A of the Show Cause Order as well as Section 284.8(d) of the Commission's regulations, GTN proposes the addition of Section 6.28.12, which provides potential replacement shippers with the requisite ability to post, for a period of twenty days, offers to acquire released firm capacity. Additionally, proposed Section 6.28.12 provides that such potential replacement shippers shall specify the terms and conditions pursuant to which capacity will be accepted.

Furthermore, upon receipt of offers to purchase released capacity, GTN will post such offers on its website under Informational Postings. Specifically, such postings would be found on GTN's Informational Postings under "Notices," subcategory "Non-Critical Postings," notice-type "Capacity Release." However, it should be noted that GTN has not received any such offers to purchase released capacity to date.
