Statement of Nature, Reasons and Basis for Filing

The report shall state the source, date, volumes, costs and revenues, and all entities from which Great Lakes' purchased or sold operational gas, for all operational purchases and sales transactions.

Great Lakes hereby notifies the Commission that it made no operational purchases or sales of gas during the twelve-month period ending December 31, 2020. Accordingly, no reportable operational purchases and sales of gas occurred during this time period.
