Pursuant to Section 4 of the Natural Gas Act and Part 154 of the Federal Energy Regulatory Commission's ("FERC" or "Commission") regulations¹ and in compliance with the Commission Order No. 587-AB filed in Docket No. RP96-1-044, *et al.*,² Great Lakes Gas Transmission Limited Partnership ("Great Lakes") hereby submits for filing a revised tariff section to be part of its FERC Gas Tariff, Third Revised Volume No. 1 ("Tariff").³ Great Lakes requests that the Commission accept the tariff section, filed herein as Appendix A, to become effective January 1, 2027.

Statement of Nature, Reasons and Basis for Filing

On May 22, 2026, the Commission issued Order No. 587-AB, amending Version 4.0 of the Wholesale Gas Quadrant (“WGQ”) Standards (“Version 4.0 Standards”) adopted by the North American Energy Standards Board (“NAESB”). The revisions included in the revised Version 4.0 Standards are designed to streamline the process for accessing publicly available gas-electric coordination data during extreme cold weather or emergency events. Natural gas pipelines were directed to submit their compliance filings by September 1, 2026, with an effective date of January 1, 2027.⁴ In compliance with Order No. 587-AB, Great Lakes has revised its Tariff section listed in Appendix A to reflect the incorporation of the updated data sets in the following Business Practice Standards:⁵

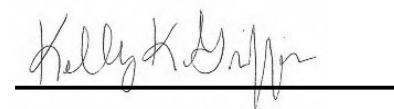
