Pursuant to Section 4 of the Natural Gas Act ("NGA"), Part 154 of the Federal Energy Regulatory Commission ("FERC" or "Commission") regulations, Rule 212 of the Commission's Rules of Practice and Procedure, and the Commission's May 29, 2025 Order Accepting and Suspending Tariff Records, Subject to Refund, and Establishing Hearing Procedures in Docket No. RP25-855-000 ("Suspension Order"), Great Lakes Gas Transmission Limited Partnership ("Great Lakes") hereby submits as part of its FERC Gas Tariff, Third Revised Volume No. 1 ("Tariff") this Type 610⁴ motion to place the certain suspended tariff records that are not subject to modification into effect on November 1, 2025.

Statement of the Nature, Reasons and Basis for Filing

On April 30, 2025, in Docket No. RP25-855-000, Great Lakes filed revised tariff records pursuant to Section 4 of the NGA and Part 154 of the Commission's regulations to implement a general rate case proposing a system-wide general increase in Great Lakes' rates and changes to various Rate Schedules and provisions of the General Terms and Conditions of its Tariff ("Rate Case Filing"). By its Suspension Order, the Commission accepted and suspended Great Lakes' tariff records to become effective upon motion November 1, 2025, subject to refund and conditions and the outcome of the hearing established in the Suspension Order.⁵

Great Lakes is submitting the instant filing to move those certain suspended tariff records not subject to modification, and listed in Appendix A, into effect November 1, 2025,⁶ consistent with Great Lakes' rights pursuant to Section 154.206 and the Suspension Order.

Motion to Place Tariff into Effect

Pursuant to Section 154.206 of the Commission's Regulations and Rule 212 of the Commission's Rules of Practice and Procedure, Great Lakes hereby moves to place those certain suspended tariff records not subject to modification, included herein as Appendix A, into effect November 1, 2025. Great Lakes requests that the Commission grant any waivers necessary for the proposed tariff records to become effective as requested herein.

Other Filings Which May Affect this Proceeding

Contemporaneously with the instant filing, Great Lakes is filing a separate Type 580 motion in Docket No. RP25-855-000 to move into effect a tariff record that has been modified to comply with Ordering Paragraph D of the Suspension Order.
